The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): August 17, 18, 19, 20, 21, 2020. An off-site interview was conducted on September 29, 2020.

The following intakes were completed in this critical incident inspection:

Log # 009826-20 related to falls prevention and management; and

Log # 015793-20 related to the prevention of abuse.

During the course of the inspection, the inspector observed resident and staff interactions, and reviewed clinical health records, relevant home policies and procedures, and other pertinent documents.

During the course of the inspection, the inspector(s) spoke with the Administrator, Program Manager, registered practical nurses (RPNs), personal support workers (PSWs), police detective and residents.

Specifically failed to comply with the following:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants :

1. The licensee has failed to ensure resident #001 was protected from abuse by Recreation Aide #110.

Section 2 (1) of the Ontario Regulation 79/10 defines sexual abuse as “any consensual or non-consensual touching, behaviour or remarks of a sexual nature or sexual exploitation that is directed toward a resident by a licensee or staff member.”

PSW #102 witnessed Recreation Aide (RA) #110 having an inappropriate interaction with resident #001. The incident was reported to registered staff and the RA was sent home pending investigation. Shortly after the incident the resident was able to recall the incident to another PSW. RA #110 was noted to have previous inappropriate interactions with staff and residents in three separate incidents. RA #110 was terminated by the home and the police filed charges the same day.

An interview with Administrator #108 stated the actions of RA #110 constituted abuse.

Findings/Faits saillants :

1. The licensee has failed to ensure that police checks for RA #110 and PSW #112 were conducted within six months before they were hired.

Records indicated that RA #110's police check was dated eight months prior to being hired and PSW #112's police check was dated 10 months prior to being hired. Administrator #108 acknowledged that police checks conducted for RA #110 and PSW #112 were not within six months of being hired.

Police checks must be conducted within six months before a staff member is hired to ensure they are current.

Additional Required Actions:

Scope: This was an isolated case as no other incidents related to sexual abuse were identified during this inspection.

Compliance History: In the last 36 months, the licensee was found to be non-compliant with the LTCHA s.19(1) and a written notice (WN) was issued.
