WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 129. Safe storage of drugs

Specifically failed to comply with the following:

s. 129. (1) Every licensee of a long-term care home shall ensure that,

(a) drugs are stored in an area or a medication cart,

(i) that is used exclusively for drugs and drug-related supplies,

(ii) that is secure and locked,

(iii) that protects the drugs from heat, light, humidity or other environmental conditions in order to maintain efficacy, and

(iv) that complies with manufacturer's instructions for the storage of the drugs; and O. Reg. 79/10, s. 129 (1).

(b) controlled substances are stored in a separate, double-locked stationary cupboard in the locked area or stored in a separate locked area within the locked medication cart. O. Reg. 79/10, s. 129 (1).

Findings/Faits saillants :

1. The licensee failed to ensure that drugs are stored in an area or a medication cart that is secure and locked.

An unlocked and unattended box of prescription treatment creams was observed at 11:30 hour on July 10, 2014, in the unlocked and unattended Oakdale nursing station.

An unlocked and unattended box of prescription treatments creams was also observed at 11:40 hour on July 10, 2014 in the unlocked and unattended Cherryhill nursing station.

A staff member verified the nursing stations were unlocked and also confirmed that the boxes of prescription creams were unlocked and unattended. [s. 129. (1) (a) (ii)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that all registered nursing staff receive education related to drugs and prescription creams being stored in an area or medication cart that is kept secure and locked, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 21. Every licensee of a long-term care home shall ensure that the home is maintained at a minimum temperature of 22 degrees Celsius. O. Reg. 79/10, s. 21.

Findings/Faits saillants :

1. The licensee failed to ensure that the home is maintained at a minimum temperature of 22 degrees Celsius.

On July 10, 2014 at 11:00 hours, 13:30 hours and 15:00 hours it was observed that the Resident Chapel temperature was 21 degrees Celsius. This was reported to the manager on site. [s. 21.]
