WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 41. Every licensee of a long-term care home shall ensure that each resident of the home has his or her desired bedtime and rest routines supported and individualized to promote comfort, rest and sleep. O. Reg. 79/10, s. 41.

Findings/Faits saillants :

1. The licensee of the long-term care home did not ensure that each resident of the home had his or her desired bedtime and rest routines supported and individualized to promote comfort, rest and sleep. The evening bedtime was observed in Cedar home area on May 22, 2012. It was noted that three residents were put to bed at 6:15pm although this time was not known to be a resident preference. The plans of care did not identify the residents' preferred bedtime. This was confirmed by the PSW on duty on this date who indicated that it was routine procedure to put the resident's to bed after supper although bedtime preferences were not known and residents were noted to be awake and alert at 17:45 during meal service.
