#### Specifically failed to comply with the following:

- s. 6. (10) The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when.
- (a) a goal in the plan is met; 2007, c. 8, s. 6 (10).
- (b) the resident's care needs change or care set out in the plan is no longer necessary; or 2007, c. 8, s. 6 (10).
- (c) care set out in the plan has not been effective. 2007, c. 8, s. 6 (10).

#### Findings/Faits saillants:

1. The licensee did not ensure that the resident was reassessed and the plan of care reviewed and revised at least every six months and at any other time when the resident's care needs changed or the care set out in the plan was no longer necessary.

An identified resident was diagnosed with an injury in February, 2012. The resident initially demonstrated change in pain levels 3 days prior to the diagnosis with observed changes in the resident's physiological status. There was no evidence of an assessment of resident pain or care needs changes for 35 hours. The DOC confirmed that ongoing assessments of the resident's needs were not completed. 2.An identified resident's quarterly care conference of February, 2012 stated the resident was very resistive to the sit/stand lift and was no longer ambulatory, but did not identify how transfers should be completed. The resident's current plan of care stated staff to provide weight-bearing physical assistance. The resident can weight bear. Staff confirmed they had completed transfers of the resident by sit/stand or hoyer lift prior to a diagnosed injury. [s. 6. (10) (b)]

#### Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when the resident's care needs change or the care set out in the plan was no longer necessary, to be implemented voluntarily.
