The licensee has failed to ensure that when a resident applied for admission to the Long-Term Care (LTC) home, they were approved, unless the home lacked the nursing expertise required to meet the applicant's care requirements.

The written notice of withholding admission indicated lack of nursing expertise and included specified grounds.

The LTC home's Director of Resident Care (DRC) indicated that staff working in the LTC home's secured home area were trained in managing a resident's responsive behaviors.
