The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): October 15-18, 2018.

The following intakes were completed during this Follow up Inspection:

One follow-up, related to O. Reg. 79/10, s. 74 (1) (2) (3), related to the Registered Dietitian being a member of the staff for the home.

One follow-up, related to O. Reg. 79/10, s. 26 (4), related to the Registered Dietitian assessments and their working hours.

A Critical Incident System Inspection #2018_669642_0026, and a Complaint Inspection, #2018_669642_0024 were completed concurrently with this Follow up Inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Assistant Director of Care (ADOC), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), family members and residents.

The Inspector also conducted a tour of resident care areas, observed the provision of care and services to residents, staff to resident interactions, reviewed relevant health care records, various licensee policies, procedures and programs and the home's incident reports and internal investigation files.
