The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): January 15, 16 & 17, 2019

Log #028383-18 - regarding a refusal of admission to the Long - Term Care home.

Log #032706-18 - regarding nutrition management and food quality concerns.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), the Office Coordinator, Resource Nurses, Registered Nurses (RN), Registered Practical Nurses (RPN), Dietary Aides/Cooks, the Registered Dietician (RD), Food and Nutrition Services Management staff, and Personal Care Assistants (PCA).

In addition, reviews of resident electronic health care records, food handler certification, daily production sheets, the Food and Sanitizing Temperature policies & procedures, the current menu, standardized recipes and the Diet Reference/Resident Profile binder were completed. Observations of the food handling process, from "truck to table", as well as interviews with residents and staff were conducted.
