The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): September 19, 2019

During this inspection, the following log was inspected:

Log #014731-19 related to an incident that causes an injury to a resident for which the resident is taken to hospital and which results in a significant change in the resident's health status.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), the Environmental Services Managers, one Registered Nurse (RN), two Registered Practical Nurses (RPN), one Personal Support Worker (PSW) and one resident.

In addition, review of resident electronic health care record and the "Floor Cleaning Process" policy, dated October 2017 were completed. Resident care observations and multiple staff interviews were conducted.
