The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): March 28, April 3, 4 and 5, and 17, 2018. Additionally, off-site interviews were conducted on April 10, 11 and May 2, 2018.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Registered Nurse (RN), Nurse Practitioner (NP), Registered Nursing student, Personal Care Providers (PCPs), coroner, police detective and substitute decision makers (SDMs).

During the course of the inspection, the inspector observed staff and resident interactions and the provision of care, and reviewed health records, investigation notes and video surveillance.
