The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): October 16, 17, 18, 21, 22, 23, 24 and 25, 2019.

The following critical incident with log# 015886-19, related to fall prevention and management, was inspected.

Two Voluntary Plan of Action related to LTCHA,2007, c.8, s. 49(2) and 48(1)4 were identified in this inspection and have been issued in a critical incident report #2019_526645_0015, dated November 21, 2019, which was conducted concurrently with this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Nurse manager (NM), Resident Assessment Instrument (RAI) Coordinators, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs) and Residents.

During the course of the inspection, the inspectors performed observations of staff and resident interactions, provision of care, reviewed residents' clinical records, medication administration records (MAR), staff training records and relevant policies and procedures.
