Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect Specifically failed to comply with the following subsections:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits sayants:

1. On 17 May 2011 the inspector confirmed the following information:

An incident of verbal abuse of a resident occurred on involving an employee and a resident. A witness overheard the employee speaking/arguing with the resident in a tone that was hostile and threatening. The witness claimed the employee was unaware of their presence and acted this way throughout the provision of care for the resident. The employee was not remorseful for the behaviour and tried to explain the resident was behaviourally difficult and profane. The employee attended an in-service on abuse and resident's rights in 2008 and this information was reviewed during a performance review in 2010.
