**During the course of the inspection, the inspector(s) spoke with 20 plus residents, three family members, one Resident Council Representative, one Family Council Representative, the Administrator, Director of Nursing and Personal Care, two Registered Nurses, two Registered Practical Nurses, six Personal Support Workers, one Occupational Therapy Aide and one Kinesiotherapist.**

**During the course of the inspection, the Inspectors toured the home, observed medication administration, medication storage areas, recreation activities, reviewed relevant clinical records, reviewed relevant policies and procedures, the provision of resident care, resident-staff interactions, posting of required information and observed general maintenance, cleaning and condition of the home.**
