The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): January 25-29, 2021.

The following intakes were completed in this follow up Inspection;

-One log related to compliance order (CO) #001 that was issued during Inspection #2020_565647_0019 ensuring that the home was compliant with s.8 (1) b of the Long-Term Care Homes Act, specifically related to the contents of the home's current Medication Reconciliation policy.

-One log related to compliance order (CO) # 002 that was issued during Inspection #2020_565647_0019 ensuring that the home was compliant with s.131 (2) of the Long-Term Care Act, specifically to ensure that medications for all residents in Lake Rousseau home area, including resident #002, #004, and #013 were administered their medications on time in accordance with the directions specified by the prescriber.

A Critical Incident Inspection # 2021_772691_0003 was conducted concurrently with this Inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Associate Director of Care, Registered Nurses (RNs), Registered Practical Nurse (RPNs), and residents.

The Inspector also conducted a daily walk through of resident care areas, observed the provision of care towards residents, relevant staff education records, reviewed relevant health care records, internal investigation documents, as well as relevant policies and procedures.
