Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.
Plan of care**

Specifically failed to comply with the following:

- s. 6. (1) Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out,**
- (a) the planned care for the resident; 2007, c. 8, s. 6 (1).**
 - (b) the goals the care is intended to achieve; and 2007, c. 8, s. 6 (1).**
 - (c) clear directions to staff and others who provide direct care to the resident. 2007, c. 8, s. 6 (1).**

Findings/Faits saillants :

1. The licensee did not ensure that there is a written plan of care for each resident that sets out clear directions to staff and others who provide direct care to the resident.
 - a) The quarterly assessment for one resident identifies the resident requires assistance of one person for transfers.
 - b) The fall assessment identifies the same resident requires extensive assistance of two staff for transfers.
 - c) The current written plan of care for the resident identifies the resident requires limited assistance for transfers and at times during the day, will transfer independently.
 - d) The written plan of care does not include the number of staff required to provide limited assistance for transfers.
 - e) Three staff confirmed the resident can transfer independently from her walker when the brakes are applied and requires assistance of one staff to transfer from her wheelchair or bed. [s. 6. (1) (c)]
