The purpose of this inspection was to conduct a Critical Incident System inspection.

log #003807-21, a critical incident related to a fall

log #007405-21, a critical incident related to a Covid-19 outbreak

Inspection #2021_605213_0015, a complaint inspection, was completed concurrently with this critical incident inspection. A finding of non-compliance related to infection control (specifically cleaning high touch surfaces and hand hygiene products), found in this inspection, has been issued in the complaint inspection .

During the course of the inspection, the inspector(s) spoke with the Revera Regional Manager, the Director of Care, the Assistant Director of Care, a Physician, the Nutrition Manager, the Recreation Manager, Registered Nurses, Registered Practical Nurses, Personal Support Workers, a Housekeeping Aide, a Dietary Aide, Pinkerton Security Staff, residents and family members.

The inspectors also made observations of residents and resident care, cleaning, and reviewed health records, policies and procedures, internal investigation records and communication, and other relevant documentation.
