The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): July 29, 30, and 31, 2019, and off-site on August 6, 2019.

The following Critical Incident System related intake was inspected during this inspection:

Log #014248-19 (CIS #2969-000034-19) related to an incident that caused an injury to a resident for which the resident was taken to the hospital and which resulted in a significant change in the resident's health status.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Corporate Clinical Manager, Registered Dietitian (RD), Food Services Manager, Dietary Staff, Behavioural Supports Ontario (BSO) Lead, Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), and Residents.

During the course of the inspection, the inspector reviewed resident's health records, relevant policies and procedures, staff training records, staffing schedule, dietary nursing meeting records, weekly and daily menus, food purchase invoice, and the home's investigation notes.
