WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 72. Food production Specifically failed to comply with the following subsections:

- s. 72. (2) The food production system must, at a minimum, provide for,
- (a) a 24-hour supply of perishable and a three-day supply of non-perishable foods;
- (b) a three-day supply of nutritional supplements, enteral or parenteral formulas as applicable;
- (c) standardized recipes and production sheets for all menus;
- (d) preparation of all menu items according to the planned menu;
- (e) menu substitutions that are comparable to the planned menu;
- (f) communication to residents and staff of any menu substitutions; and
- (g) documentation on the production sheet of any menu substitutions. O. Reg. 79/10, s. 72 (2).

Findings/Faits saillants:

1. The licensee did not ensure the preparation of all menu items according to the planned menu.

At lunch on Oct. 24th, 2012 the planned menu included a cheese and fruit plate.

The pureed textured cheese and fruit plate served provided one fruit serving of pureed peaches with applesauce. The recipe called for pineapple, watermelon and pears to be pureed separately. The pureed cheese and fruit plate served included pureed cottage cheese with pureed cheddar however the recipe called for pureed cheddar cheese. Pureed bread or a pureed muffin was not provided with the cheese and fruit plate contrary to the planned menu. Portion sizes for pureed items on the plate were not available in the recipe.

The minced textured cheese and fruit plate included a small amount of grated cheedar cheese however the recipe called for 50gms of sliced regular cheedar cheese. A mixture of fruit was minced together with no direction to do so. The Food Service Supervisor stated that the recipes were not followed and did not provide clear direction to staff. [r. 72.
