WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 35. Foot care and nail care

Specifically failed to comply with the following:

s. 35. (2) Every licensee of a long-term care home shall ensure that each resident of the home receives fingernail care, including the cutting of fingernails. O. Reg. 79/10, s. 35 (2).

Findings/Faits saillants :

1. The licensee has failed to ensure that the resident receives fingernail care.

Observation of an identified resident revealed that the resident was participating in a recreation program and had dried debris on 7 of 10 fingernails.

The home's policy, Basic Care RC-C-05, November 2009, indicates the following:

6. Nail Care

*Fingernails will be cared for at the time of the Resident's bath/shower or more frequently if required

A Registered Staff also observed the resident's nails and confirmed that there was dried debris present. The Registered Staff indicated that the expectation was that the resident would receive fingernail care that included the cleaning of nails when required, and had a Personal Care Worker complete the care to the nails immediately.

The Director of Care confirmed that it is the expectation that all residents will have their nails cleaned as required. [s. 35. (2)]
