The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): July 19-22, 2016.

This inspection was conducted as a result of a Critical Incident report the home submitted to the Director outlining allegations of resident to resident sexual abuse.

A concurrent Complaint inspection was conducted related to the same residents identified in the Critical Incident.

During the course of the inspection, the inspector(s) spoke with the Administrator, Activation Manager, Maintenance Manager, Nutrition Manager, Physiotherapist, Ward Clerk, Supply Purchaser, Medical Director, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Maintenance Workers, Housekeepers, Behavioural Supports Ontario (BSO) Workers, residents and family of residents.

The inspector(s) also conducted a daily tour of resident care areas, observed the provision of care and services to residents, reviewed numerous licensee policies, procedures, and programs, complaint logs, internal investigations, relevant health care records, staffing schedules, human resource files, and training logs.

During the course of this inspection, Non-Compliances were not issued.
