The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): January 16th and 19th, 2015.

During the course of the inspection, the inspector(s) spoke with the Director of Long Term Care and Services for Seniors, the Administrator, the Director of Care, a Registered Nurse, a Registered Practical Nurse, a Social Worker, an attending Physician and a Police Officer.

The Inspector reviewed a resident health care record inclusive of a plan of care, assessments, physician orders, progress notes, policies and procedures related to the management of sentinel events, adverse events and near misses, security and incident reports and resident safety plans as well completed a tour of a resident home area and a resident bedroom.
