WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 3. Residents' Bill of Rights

Specifically failed to comply with the following:

- s. 3. (1) Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:
- 14. Every resident has the right to communicate in confidence, receive visitors of his or her choice and consult in private with any person without interference. 2007, c. 8, s. 3 (1).

1. The Licensee has failed to fully respect and promote that every resident had the right to receive visitors of his or her choice.

COVID-19 Directive #3 for Long-Term Care Homes under the LTCHA, 2007 issued under section 77.7 of the Health Protection and Promotion Act (HPPA), R.S.O 1990, c.H.7 states that Long-Term Care Homes must have a visitor policy in place that is compliant with this Directive and is guided by applicable policies, amended from time to time, from the MLTC (Ministry of Long-Term Care).

Policy "COVID-19: visiting long-term care homes", is a supplement to Directive #3 and was last updated December 26, 2020. The policy indicates that "a caregiver is a type of essential visitor who is designated by the resident and/or their substitute decision maker and is visiting to provide direct care to the resident (eg. supporting feeding, mobility, personal hygiene, cognitive stimulation, communication, meaningful connection, relational continuity and assistance in decision making)". It further states that 2 caregivers may be designated per resident at a time and that the decision to designate an individual as a caregiver is entirely the remit of the resident and/or their substitute decision-maker and not the home.

The licensee created and implemented a policy titled "Approving Essential Caregiver Visitors" revised December 2020, whereby the home reviews all requests for an individual to be an essential caregiver and determines if they will be approved.

Effective December 26, 2020 the home reviewed the number of essential caregivers who could enter the home, stated their criteria was if the essential care giver was not providing something that the staff could not provide, they were precluded from visiting.

The home indicated wanting some control over the number of essential visitors allowed to enter the home. As a result, the residents' right to receive visitors of their choice was not fully respected and promoted.

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the following rights of residents are fully respected and promoted: 14. Every resident has the right to communicate in confidence, receive visitors of his or her choice and consult in private with any person without interference, to be implemented voluntarily.
