The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with the Director of Care, Housekeeping and Laundry Supervisor and housekeeping staff.

During the course of the inspection, the inspector(s) randomly toured resident bedrooms, dining rooms and common areas on 4 home areas on the North side of the complex and reviewed the home's housekeeping schedules and policies and procedures.

Specifically failed to comply with the following:

s. 87. (2) As part of the organized program of housekeeping under clause 15 (1) (a) of the Act, the licensee shall ensure that procedures are developed and implemented for,

(a) cleaning of the home, including,

(i) resident bedrooms, including floors, carpets, furnishings, privacy curtains, contact surfaces and wall surfaces, and

(ii) common areas and staff areas, including floors, carpets, furnishings, contact surfaces and wall surfaces; O. Reg. 79/10, s. 87 (2).

Findings/Faits saillants :

[O. Reg. 79/10, s.87(2)(a)(i)] As part of the organized program of housekeeping under clause 15 (1) (a) of the Act, the licensee has not ensured that procedures which have been developed are implemented for, (a) cleaning of the home, including, (i) resident bedrooms, including floors, carpets, furnishings, privacy curtains, contact surfaces and wall surfaces.

With respect to residents' rooms, the home has developed a cleaning schedule and procedures under their policies titled "Furniture Care", "Damp Dusting" and "Daily Cleaning - Resident Rooms". The schedule directs staff to complete a "deep" dust and vacuum of resident rooms once per week and the policies direct staff to damp dust or spot clean ledges, shelves, miscellaneous furniture, etc. on a daily basis. Based on the observations below, it appears that the home has not implemented the policies completely.

Resident rooms located on the 4th, 2nd and 1st floor home areas of the North Tower were observed to be dusty. The majority of rooms on the 4th and 2nd floors were observed to have dusty decorative wood wall mouldings, wardrobe tops, overbed shelving, and shelving in resident bathrooms. With the exception of the mouldings, the dusty surfaces are all high, hard to reach areas which would require staff to use a step stool. Out of the rooms observed, approximately 25% had excessive amounts of dust on wardrobe and shelving surfaces which could be picked up on the fingers and rolled.
