The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): October 5 - 8, 2020.

The following intakes were completed in this Follow Up inspection:

-one log related to CO #001 from Inspection Report #2020_782736_0007, LTCHA, 2007 S.O. 2007, c.8, s. 24. (1), specific to ensuring that all allegations of resident abuse or neglect are immediately reported to the Director, and

-one log related to CO #001 from Inspection Report #2020_782736_0008, LTCHA, 2007, c. 8, s. 20 (1), specific to ensuring that without in any way restricting the generality of the duty provided for in section 19, every licensee shall ensure that there is in place a written policy to promote zero tolerance of abuse and neglect of residents, and shall ensure that the policy is complied with.

During the course of the inspection, the inspector(s) spoke with the Executive Director (ED), Staffing Development Coordinator, Social Services Coordinator, Environmental Services Manager (ESM), Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), Dietary Aides, Housekeepers, and residents.

During the course of the inspection, the Inspector(s) also conducted a daily tour of the resident care areas, observed staff to resident interactions, resident to resident interactions, and the provisions of care, reviewed internal documents, and policies and procedures.
