The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): July 27-30, and August 3-5, 2021.

During this inspection, the following log was inspected:

-one log related to Compliance Order #001 from inspection #2021_565647_0009, regarding s. 3. (1) of the Long Term Care Act, where the Home was required to facilitate residents in receiving visitors, specifically essential caregivers, in accordance with the COVID-19 Directive #3 for Long-Term Care Homes (Directive #3) under the Long-Term Care Homes Act, 2007 (LTCHA) issued by the Chief Medical Officer of Health; the Minister of Long-Term Care's Directive: COVID-19: Long-Term Care Home Surveillance Testing and Access to Homes (Minister's Directive); and, the COVID-19 Visiting Policy. The compliance due date was April 30, 2021.

During the course of the inspection, the inspector(s) spoke with the Executive Director, Director of Care, Infection Prevention and Control Manager, and the COVID-19 Screener.

During the course of the inspection, the Inspector observed the entry and exit of essential caregivers and general visitors to the home, and interactions between staff and visitors, as well as reviewed relevant licensee policies and communications to families.
