Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

Le non-respect des exigences de la Loi de 2007 sur les foyers de soins de longue durée (LFSLD) a été constaté. (Une exigence de la loi comprend les exigences qui font partie des éléments énumérés dans la définition de « exigence prévue par la présente loi », au paragraphe 2(1) de la LFSLD.

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 8. Nursing and personal support services**

**Specifically failed to comply with the following subsections:**

**s. 8. (3) Every licensee of a long-term care home shall ensure that at least one registered nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times, except as provided for in the regulations. 2007, c. 8, s. 8 (3).**

**Findings/Faits saillants :**

1. Inspector did not observe an RN on duty and present in the home on December 6, 2011 at 1220hrs.
2. An interview was conducted with a PSW on December 6, 2011 at 1220hrs. This staff member stated that there is "no RN on this side" and that the "RN is available by pager and is on the acute side of the building".
3. An interview was conducted with the Director of Nursing for both the acute and long-term care units of McCausland Hospital on December 6, 2011 at 1245hrs. The DOC stated "at present there is not an RN scheduled to work on the long-term care unit" and "there is a RN working on the acute side of the hospital that is assigned charge for the long-term care unit on both day and night shifts".

The licensee of the home failed to ensure that at least one registered nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times, except as provided for in the regulations [LTCHA 2007,S.O.2007,c.8,s.8(3)].

**Additional Required Actions:**

**VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance that ensures that at least one registered nurse who is both an employee of the home and a member of the regular nursing staff of the home is on duty and present in the home at all times, except as provided for in the regulations, to be implemented voluntarily.**
