The licensee has failed to ensure that when withholding approval for admission to the home, there was a written notice setting out: a detailed explanation of the supporting facts, as they related to both the home and the applicant's condition and requirements for care; an explanation of how the supporting facts justified the decision to withhold approval; and contact information for the Director.

Applicant #001 was residing in the community. The family had requested long-term care home placement related to concerns regarding safety.

A Community Care Access Centre (CCAC) Care Coordinator completed an assessment and determined the applicant was eligible for long-term care placement.

The licensee withheld approval for admission and sent a refusal letter to the applicant.

The letter did not include a detailed explanation of supporting facts as they relate to the grounds for refusal as specified in the Act s.44(7) that either the home lacks the physical facilities to meet the applicant's care requirements or the home lacks the nursing expertise necessary to meet the applicant's care requirements.

The letter did not include an explanation of how the supporting facts justify the decision to withhold approval.

The letter did not include contact information for the Director.

In an interview, the Administrator acknowledged that the letter did not include the required information in accordance with the legislation.

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that when the licensee withholds approval for admission, persons described in subsection (10) are given a written notice that includes all of the following: the ground or grounds on which the licensee is withholding approval; a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; an explanation of how the supporting facts justify the decision to withhold approval; and contact information for the Director, to be implemented voluntarily.***
