The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): November 12, 13, 14, 15 and 20, 2019.

The following Follow-up intakes were completed within this inspection:

Log #020088-19 for Compliance Order (CO) #001 from Inspection #2019_788721_0032 related to plan of care for bathing and repositioning; and Log #020089-19 for CO #002 from Inspection #2019_788721_0032 related to plan of care for bathing and toileting.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care, two Associate Directors of Care, the Assistant Manager of Informatics, the Business Manager, a Social Worker, a Receptionist, a Registered Nurse, two Registered Practical Nurses, four Personal Support Workers, residents and visitors.

The Inspectors also observed residents and the care provided to them and reviewed clinical records and plans of care for the identified residents.
