WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 25. Initial plan of care

Specifically failed to comply with the following:

- s. 25. (1) Every licensee of a long-term care home shall ensure that,**
(a) the assessments necessary to develop an initial plan of care under subsection 6 (6) of the Act are completed within 14 days of the resident's admission; and O. Reg. 79/10, s. 25 (1).
(b) the initial plan of care is developed within 21 days of the admission. O. Reg. 79/10, s. 25 (1).

Findings/Faits saillants :

1. Resident #5 was admitted to the Lennox and Addington County General Hospital, Convalescent Care Unit on a specified date. A review of resident #5's health care record indicated that the initial plan of care was not completed.

Resident #2 was admitted on a specified date. A review of the electronic health care record indicated that the initial plan of care was not developed.

The inspector was informed by the Charge Nurse (Registered Nurse) that the home was having issue's with completing care plans within the Point Click Care tool.

The licensee has failed to comply with Ontario Regulation 79/10 section 25.(1)(b) by not ensuring that the initial plan of care is developed within 21 days of admission. [s. 25. (1) (b)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that all residents have an initial plan of care developed, to be implemented voluntarily.
