Inspection Summary/Résumé de l'inspection



The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): September 18, 2015

This inspection was conducted regarding a Critical Incident#3046-000076-15 related to skin and wound care.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care, one Registered Staff member and two Personal Support Workers. The Inspector also reviewed a resident clinical record, the homes policy regarding skin and wound care as well as observing general and specific resident care.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 50. Skin and wound care



Specifically failed to comply with the following:

- s. 50. (2) Every licensee of a long-term care home shall ensure that,**
- (b) a resident exhibiting altered skin integrity, including skin breakdown, pressure ulcers, skin tears or wounds,**
- (i) receives a skin assessment by a member of the registered nursing staff, using a clinically appropriate assessment instrument that is specifically designed for skin and wound assessment,**
 - (ii) receives immediate treatment and interventions to reduce or relieve pain, promote healing, and prevent infection, as required,**
 - (iii) is assessed by a registered dietitian who is a member of the staff of the home, and any changes made to the resident's plan of care relating to nutrition and hydration are implemented, and**
 - (iv) is reassessed at least weekly by a member of the registered nursing staff, if clinically indicated; O. Reg. 79/10, s. 50 (2).**

Findings/Faits saillants :

1. The licensee failed to ensure that a resident exhibiting altered skin integrity, including skin breakdown, pressure ulcers, skin tears or wounds is assessed by a registered dietitian who is a member of the staff of the home, and any changes made to the resident's plan of care relating to nutrition and hydration are implemented, and is reassessed at least weekly by a member of the registered nursing staff, if clinically indicated.

A resident was noted to have altered skin integrity that required medical attention. Review of the clinical record revealed no referral to the Dietitian was initiated and weekly documentation was not completed. This was confirmed by two Registered Staff members.

The Director of Care confirmed that the expectation was that all areas of altered skin integrity be assessed weekly by a registered staff member using a clinically appropriate tool and that the Dietitian received a referral for all wounds. [s. 50. (2) (b)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that a resident exhibiting altered skin integrity, including skin breakdown, pressure ulcers, skin tears or wounds is assessed by a registered dietitian who is a member of the staff of the home, and any changes made to the resident's plan of care relating to nutrition and hydration are implemented, and is reassessed weekly by a member of the registered staff, if clinically indicated, to be implemented voluntarily.
