**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.
Plan of care**

Specifically failed to comply with the following:

s. 6. (10) The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when,

(a) a goal in the plan is met; 2007, c. 8, s. 6 (10).

(b) the resident's care needs change or care set out in the plan is no longer necessary; or 2007, c. 8, s. 6 (10).

(c) care set out in the plan has not been effective. 2007, c. 8, s. 6 (10).

Findings/Faits saillants :

1. The Licensee failed to ensure that the resident was reassessed and the plan of care reviewed and revised when the resident's care needs changed as evidenced by the following:

Record review revealed that the Laboratory results verified that the resident had an infection; however the doctor was not notified of the resident's change in condition.

In an interview the Registered staff member confirmed that the Laboratory results ``had been missed`` and should have been reviewed with the Physician when the home had received the results.

During an interview the Acting Director of Care confirmed her expectations that residents are reassessed and the plan of care is reviewed and revised at least every six months and at any other time when the resident's care needs change. [s. 6. (10) (b)]
