The purpose of this inspection was to conduct an Other inspection.

This inspection was conducted on the following date(s): August 4, 2016.

The purpose of this inspection was to conduct a post occupancy inspection. The home began the admission of residents on June 28, 2016. During this inspection, the Inspector observed required postings that consisted of Resident Rights, the home's mission, vision and values, complaint process including the posting of the Ministry of Health and Long Term Care action telephone number, the duty to make a mandatory report policy, the home's policy to minimizing restraining, the LHIN Service Accountability Agreement, the name and telephone number of the licensee, Fire procedures including evacuation procedures, Whistleblower protection policy and the home's Zero tolerance to Abuse and Neglect policy. The Inspector reviewed policies, staffing schedules, pre-occupancy inspection report and residents' clinical records. The Inspector conducted a tour of each resident home area and observed indoor and outdoor seating areas, spa areas, resident rooms, common areas and dining rooms. The inspector spoke with the lead for Training and Orientation and reviewed staff training and orientation materials. The inspector observed residents during a meal service and interviewed residents, family members and staff. No findings of non-compliance were identified as a result of this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, Staff Educator, Restorative Care Coordinator, Staffing Coordinator, Registered staff, residents and families.
