Duty to protect

s. 24 (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff.

The licensee has failed to ensure that a resident was protected from abuse by staff.

A Personal Support Worker (PSW) reported to registered staff that while they and another PSW had provided care to a resident, the other PSW was abusive towards the resident.

Reporting certain matters to Director

- s. 28 (1) A person who has reasonable grounds to suspect that any of the following has occurred or may occur shall immediately report the suspicion and the information upon which it is based to the Director:
- 2. Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident.

The licensee has failed to ensure that the witnessed incident of abuse towards a resident was reported immediately to the Director.

There had been an allegation of staff to resident abuse that had been reported, and it had not been reported to the Director immediately.
