1. The licensee has failed to ensure that hazardous substances are kept inaccessible to residents at all times.

A utility cart containing hazardous substances was placed in an unlocked resident room during a recent home evacuation drill.

A Personal Support Worker found a Resident had accessed the hazardous substance.

Record review of the incident notes revealed that miscommunication had occurred amongst workers and that the utility cart housing hazardous substances was not put in a secure environment and was therefore accessible to residents.

Review of the home's Safety Policy and Procedure Manual under policy HR-SF-9.5 Section WHMIS Subject Worker Responsibilities states "Purpose: To ensure that employees are aware of their responsibilities in the handling of controlled products" and "Procedure #7 Employees are required to participate in WHMIS training and engage in safe work practices at all times."

Interview with the Director of Care confirmed that this incident occurred as stated in the Environmental Services Managers incident notes and that it is the home's expectation that utility carts housing hazardous substances should not be left unattended or in unlocked rooms and accessible to residents. The Director of Care also confirmed that education has been initiated and is ongoing with respect to the safe handling and storage of hazardous material. [s. 91.]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance The Licensee shall ensure that all hazardous substances at the home are labelled properly and are kept inaccessible to residents at all times. O. Reg. 79/10, s. 91., to be implemented voluntarily.
