Findings/Faits saillants:

1. The licensee has failed to ensure that there was a written plan of care for each resident that sets out, the planned care for the resident; the goals the care is intended to achieve; and clear directions to staff and others who provide direct care to the resident as evidenced by;

Observations of Resident #01 revealed a change in skin condition.		

A review of the Care Plan revealed there was no planned care in the plan of care regarding the change in skin condition.

An interview with the Assistant Director of Care confirmed it is the homes expectation that all care plans give clear directions to staff and others who provide direct care to the Resident. [s. 6. (1) (c)]

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 134. Residents' drug regimes

Every licensee of a long-term care home shall ensure that,

- (a) when a resident is taking any drug or combination of drugs, including psychotropic drugs, there is monitoring and documentation of the resident's response and the effectiveness of the drugs appropriate to the risk level of the drugs;
- (b) appropriate actions are taken in response to any medication incident involving a resident and any adverse drug reaction to a drug or combination of drugs, including psychotropic drugs; and
- (c) there is, at least quarterly, a documented reassessment of each resident's drug regime. O. Reg. 79/10, s. 134.

Findings/Faits saillants:

1. The licensee has failed to ensure that monitoring of the resident's responses to and the effectiveness of the pain management strategies are completed as evidenced by;

An interview with Resident #01 revealed they were in pain all over.

An interview with the staff revealed administration of medication had been given to Resident #01 at an earlier time in the day. The interview continued to reveal the staff did not have knowledge of the effectiveness of the administered medication.

A record review of the documentation revealed no documented responses and effectiveness of the administered medication to Resident #01 at that time.

A follow up interview with the Assistant Director of Care confirmed the Resident response to the effectiveness of the medication administration had not been completed and it is the homes expectation that monitoring of the resident's responses to and the effectiveness of the management strategies are completed.
