WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 95. Licence required

Specifically failed to comply with the following:

s. 95. (1) No person shall operate residential premises for persons requiring nursing care or in which nursing care is provided to two or more unrelated persons except under the authority of a licence under this Part or an approval under Part VIII. 2007, c. 8, s. 95. (1).

Findings/Faits saillants :

1. An off-site inquiry conducted by telephone with the Administrator on October 10, 2013 at 2 pm confirmed that a Licence for twelve convalescent care beds currently being operated has not been received by the Home.

The Administrator confirmed that admissions to the convalescent care beds began on April 29, 2013 and have been operating at approximately 80% occupancy since that date. [s. 95. (1)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance with ensuring that a license to operate beds is received prior to accepting admissions to the home for persons requiring nursing care, to be implemented voluntarily.
