### **Specifically failed to comply with the following:**

- s. 15. (2) Every licensee of a long-term care home shall ensure that,**  
**(a) the home, furnishings and equipment are kept clean and sanitary; 2007, c. 8,  
s. 15 (2).**  
**(b) each resident's linen and personal clothing is collected, sorted, cleaned and  
delivered; and 2007, c. 8, s. 15 (2).**  
**(c) the home, furnishings and equipment are maintained in a safe condition and  
in a good state of repair. 2007, c. 8, s. 15 (2).**

### **Findings/Faits saillants :**

The Licensee failed to ensure that the home, furnishings and equipment are kept clean and sanitary as evidenced by:

- a) In a dining room, observed that the window ledge was very dusty.
- b) A standing fan in hallway across from a nurses station, had blades that were coated in dust.
- c) Flowers on a wall between a bathing suite and a laundry room were coated in dust.
- d) A disposable glove holder sleeve on the wall, had noticeable dust on the top surface.
- e) A hanging flower arrangement on the wall outside of a resident room, had a large build-up of dust.
- f) In a resident room, the dresser was very dusty.
- g) The frame of a picture hanging on the hallway wall across from a resident room, was coated in dust.
- h) A standing fan outside of a resident room, had blades that were dusty/dirty.
- i) A statue in the Alcove by the elevators on the second floor was very dusty. [s. 15.
