Critical Incidence Reports, 0965-000006-15 and 0965-000005-15 were conducted concurrently.

During the course of the inspection, the inspector(s) spoke with the Acting Administrator, A Registered Nurse, a Registered Practical Nurse and a Personal Support Worker.

The Licensee reported through the Critical Incident System, allegations of abuse from staff to resident.

The Inspector reviewed medical records, home's policy on abuse, the home's investigation files and toured the home area.

Specifically failed to comply with the following:

s. 24. (1) A person who has reasonable grounds to suspect that any of the following has occurred or may occur shall immediately report the suspicion and the information upon which it is based to the Director:

- 1. Improper or incompetent treatment or care of a resident that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 2. Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 3. Unlawful conduct that resulted in harm or a risk of harm to a resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 4. Misuse or misappropriation of a resident's money. 2007, c. 8, s. 24 (1), 195 (2).**
- 5. Misuse or misappropriation of funding provided to a licensee under this Act or the Local Health System Integration Act, 2006. 2007, c. 8, s. 24 (1), 195 (2).**

Findings/Faits saillants :

1. A person, who had reasonable grounds to suspect abuse of a resident, has failed to ensure that the suspicion and the information upon which it was based, was immediately reported to the Director.

Review of Critical Incident Report (0965-000005-15) revealed that the incident occurred on a specific day and the Administrator reported to the Ministry at a later date.

Review of the home investigation file revealed that the Administrator initiated the home investigation on a specific date and was aware of the incident at that time.

Review of Critical Incident Report (0965-000006-15) revealed that the incident occurred on a specific date and the Administrator reported to the Ministry at a later date.

Review of the home investigation file revealed that the Administrator initiated the home investigation on a specific date and was aware of the incident at that time.

Acting Administrator confirmed that the two incidents were not reported immediately to the Director. [s. 24. (1)]
