s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

1. The licensee failed to ensure that the plan of care provided to the resident was as specified in the plan.

Review of Point Click Care (PCC) documentation on September 23, 2015, revealed that resident # 061 had a bed alarm when in bed.

On September 24, and 25, 2015, during resident observation it was noted that the bed was in the lowest position and there was no alarm attached to the bed.

The Nurse confirmed on September 24, 2015, that Resident # 061 used a bed alarm when in bed.

The Personal Support Worker confirmed on September 24, and 25, 2015, that Resident # 061 did not use a bed alarm when in bed.

The Administrator confirmed that it was the homes expectation to ensure that the plan of care provided to the resident was specified in the plan and interventions were in place.

The licensee failed to ensure that Resident # 061's Plan of Care provided to the resident as specified in the plan. [s.6.(7)] (610) [s. 6. (7)]

## Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the care set out in the plan of care is provided to the resident as specified in the plan, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records

Specifically failed to comply with the following:

s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,

(a) is in compliance with and is implemented in accordance with applicable requirements under the Act; and O. Reg. 79/10, s. 8 (1).
(b) is complied with. O. Reg. 79/10, s. 8 (1).

## Findings/Faits saillants :

1. The licensee failed to ensure that any plan, policy, protocol, procedure, strategy or system instituted or otherwise put in place was

in compliance with and was implemented in accordance with all applicable requirements under the Act, and complied with.

A review of Point Click Care (P.C.C.) documentation showed that Resident # 061 had a fall.

The homes "Fall Prevention Policy" included that a Fall Risk Assessment form would be completed on admission, quarterly, and post-fall to identify the level of risk for the resident.

Further review of P.C.C. showed that there was no completed Fall Risk Assessment, post-fall or for the quarterly review.

The Administrator confirmed on September 23, 2015, that a Fall Risk Assessment should be completed after each fall.

The licensee has failed to ensure that any plan, policy, protocol, procedure, strategy or system instituted or otherwise put in place for resident # 061 was in compliance with and was implemented in accordance with all applicable requirements under the Act, and complied with.
