The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): May 30 - June 3, 2016

This Follow up Inspection was conducted as a result of a Compliance Order (CO #001) issued previously during a Resident Quality Inspection, 2016_395613_0001 (January 4-8 and 11-15, 2016) related to ensuring the home was a safe and secure environment for its residents.

During the course of the inspection, the inspector(s) spoke with the Executive Director of Care (EDOC), Registered Nurse (RN) Supervisor, Maintenance staff, Housekeeping staff and a Personal Support Worker.

During the Follow up Inspection, the Inspector conducted a walk through of the resident home areas and made direct observations of residents' beds and mattresses, reviewed the home's Bed Safety Program 2016, Bed Safety Assessments and Bed System Measurement Device Test Results Worksheets and the manufacturer's instructions for Joerns 300 Series Bed Model 330 and Installing Mattress Side Stop.

A concurrent Complaint Inspection #2016_395613_0008 and Critical Incident Inspection #2016_395613_0010 were also conducted during this inspection.
