WN #1: The Licensee has failed to comply with LTCHA, 2007, s. 44. Authorization for admission to a home

Findings/Faits saillants:

1. The licensee failed to ensure that an application for admission was approved unless, (a) the home lacked the physical facilities necessary to meet the applicant's care requirements; (b) the staff of the home lacked the nursing expertise necessary to meet the applicant's care requirements; or (c) circumstances existed which were provided for in the regulations as being a ground for withholding approval.

In November, 2017, the home provided a written letter to an applicant that indicated that their acceptance for admission had been declined after review of the resident's behavioural and medical information.

The letter indicated that the applicant's responsive behaviours would pose a significant risk to co-residents and staff. The applicant's triggers for their responsive behaviours were not ones that could be eliminated in their environment as the home had limited resources. The letter also stated that the home did not have the expertise or resources to adequately or safely provide the level of care that the applicant required.

During an inspection conducted on December 13, 2017, the Director of Care (DOC) confirmed that the home had denied the applicant admission to their home based on the applicant's responsive behaviours stating that the home's staffing levels could not meet the applicant's needs.

It was confirmed through review of documentation and during interview with the DOC that the reason for this refusal did not meet the grounds for withholding approval as specified in the legislation.

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that an application for admission is approved unless, (a) the home lacks the physical facilities necessary to meet the applicant's care requirements; (b) the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or (c) circumstances exist which are provided for in the regulations as being a ground for withholding approval, to be implemented voluntarily.
