**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 107. Reports re critical incidents**

**Specifically failed to comply with the following:**

**s. 107. (3) The licensee shall ensure that the Director is informed of the following incidents in the home no later than one business day after the occurrence of the incident, followed by the report required under subsection (4):**

**4. An injury in respect of which a person is taken to hospital. O. Reg. 79/10, s. 107 (3).**

**Findings/Faits saillants :**

The licensee failed to ensure that the Director was informed of the following incidents in the home no later than one business day after the occurrence of the incident, followed by the report required under subsection (4): 4. An injury in respect of which a person was taken to hospital. O. Reg. 79/10, s. 107 (3).

The Ministry of Health and Long Term Care (MOHLTC) received three Critical Incident Report (CIS) submitted by the home related to falls with injury that had resulted in a transfer to the hospital for three identified residents.

A review of record documentation for three identified residents showed that the home was aware of each resident's injury for the three identified residents that were taken to hospital and the occurrences of the incidents had not been reported to the Director.

Interview with the DOC stated that the home's expectation was that they were to report to the MOHLTC within one business for injury that resulted in a transfer to hospital and had failed to do so for the identified residents.
