Specifically failed to comply with the following:

- s. 44. (7) The appropriate placement co-ordinator shall give the licensee of each selected home copies of the assessments and information that were required to have been taken into account, under subsection 43 (6), and the licensee shall review the assessments and information and shall approve the applicant's admission to the home unless,**
- (a) **the home lacks the physical facilities necessary to meet the applicant's care requirements; 2007, c. 8, s. 44. (7).**
- (b) **the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or 2007, c. 8, s. 44. (7).**
- (c) **circumstances exist which are provided for in the regulations as being a ground for withholding approval. 2007, c. 8, s. 44. (7).**

Findings/Faits saillants :

1. The licensee has failed to approve the applicant's admission to the home unless the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements.

A complaint was received on a certain date by the Ministry of Health and Long-Term Care (MOHLTC) infoline related to the home's application refusal.

A review of the home's rejection letter showed reasons for rejection that included "Our staff are limited in their interventions that they may employ, and lack the nursing expertise to care for the applicant; as a result, we would not be able to safely provide the level of care and attention that the applicant would require to meet their care needs".

Record review and staff interview showed that the home did not seek necessary information to confirm the applicant's current needs before they rejected the application.

The DOC said that they could not confirm that they had the nursing expertise necessary to meet the applicant's care requirements as they did not know the actual care requirements needed.

In an interview the Administrator said that the expectation was for the home to approve the applicant's admission unless the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements. [s. 44. (7) (b)]
