During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), the Resident Care Co-ordinator (RCC)/Wound Care Lead, the Nursing Administration Services Manager, Personal Support Workers (PSWs), family members and residents.

The inspectors also observed resident rooms and common areas, observed medication administration, observed meal and snack service, observed residents and the care provided to them, reviewed health care records and plans of care for identified residents, reviewed policies and procedures of the home, reviewed the written staffing plan of the home, reviewed staff assignment sheets, reviewed various meeting minutes and reviewed the written record of the annual evaluation of the written staffing plan.
