- (c) the home, furnishings and equipment are maintained in a safe condition and in a good state of repair. 2007, c. 8, s. 15 (2).

Findings/Faits saillants:

1. The licensee has failed to ensure that the home, furnishings and equipment were maintained in a safe condition and in a good state of repair.

The Ministry of Long-Term Care received a complaint related to maintenance concerns in the home.

Review of the Chartwell Policy titled "General Maintenance" "Preventative Maintenance & Schedules/Calendar" last revised on a specified date documented the following:

-"Chartwell requires the chattels and equipment, structure and property to be maintained in safe operating condition for all persons and to maintain the value of the property".

Observations by inspector #745 during the inspection identified peeling paint and plaster and missing ceiling tiles and exposed pipes on one specified home area. Holes in the walls and peeling paint where the old handrails had been removed on another specified home area. Large areas of missing paint, with exposed plaster below the window sill in an identified residents room.

During an interview with Maintenance Aid #100, they stated they were responsible to complete home repairs and maintenance in the home. They stated that things in a good state of repair means they were operating properly, safely, and damage should have been repaired. During a tour of the home with inspector #745, Maintenance Aid #100 stated the peeling paint and plaster and the missing ceiling tiles on an identified home area, the holes and missing paint near the new hand rails on another identified home area and the areas under the window sill missing paint and plaster in an identified residents room were not in a good state of repair.

During an interview with Administrator #101 they stated the maintenance lead and maintenance aid were responsible for ensuring that areas of disrepair were addressed. They confirmed that there was an action plan with strategies to address areas of disrepair. During a tour of the home with inspector #745, Administrator #101 stated the peeling paint and plaster and the missing ceiling tiles on an identified home area, the holes and missing paint near the new hand rails on another identified home area and the areas under the window sill missing paint and plaster in an identified residents room were not in a good state of repair.

The licensee has failed to ensure that the home was maintained in a good state of repair. S. 15 (2) (c) [s. 15. (2) (c)]
