During the course of the inspection, the inspector(s) spoke with the interim Executive Director (ED), the interim Director of Care (DOC), Behaviour Support Ontario (BSO) Registered Nurse (RN) and BSO Person Support Worker (PSW), Resident Assessment Instrument Coordinator (RAI-C), PSWs and residents.
