Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): May 14, 17, 18 and 19, 2021.

The following intakes were inspected;

One Intake, related to a medication incident and

One intake, related to a fall with an injury.

During the course of the inspection, the inspector(s) spoke with the Executive Director of Care (EDOC), the Medical Director (MD), Registered Nurse Supervisors (RN), Environmental Supervisor, Registered Practical Nurses (RPN), Personal Support Workers (PSWs), Infection Prevention and Control lead and residents.

The Inspector also conducted a daily tour of resident care areas, observed the provision of care and services to residents, observed staff to resident interactions and resident to resident interactions, reviewed relevant health care records, internal investigation notes as well as relevant policies and procedures.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (a requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA).

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Le non-respect des exigences de la Loi de 2007 sur les foyers de soins de longue durée (LFSLD) a été constaté. (une exigence de la loi comprend les exigences qui font partie des éléments énumérés dans la définition de « exigence prévue par la présente loi », au paragraphe 2(1) de la LFSLD).

Ce qui suit constitue un avis écrit de non-respect aux termes du paragraphe 1 de l'article 152 de la LFSLD.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 131. Administration of drugs

Specifically failed to comply with the following:

s. 131. (2) The licensee shall ensure that drugs are administered to residents in accordance with the directions for use specified by the prescriber. O. Reg. 79/10, s. 131 (2).

Findings/Faits saillants :

1. The licensee has failed to ensure that a resident was administered drugs in accordance with the directions for use specified by the prescriber.

It was documented that a resident's health status was deteriorating prior to the medication error. The Medical Director (MD) had arrived at the home to conduct an assessment, which resulted in new medication orders and an order to transfer the resident to the hospital for further assessment. The MD had written orders to administer two specific medications by mouth, one time only. A RPN administered the incorrect dosage and route of the medications.

Based on the amount of medication that the resident received there was risk of harm to the resident's health.

During an interview with the EDOC and the MD, both indicated that the RPN made the medication error when they administered the two medications.
