1. The Licensee has failed to ensure that a resident's written record is kept up to date at all times

Chart review revealed no documentation related to an assessment not occurring. Interview with the Resident Care Coordinator revealed the home's expectation would be that there would be documentation in a resident's health care record explaining why an assessment was not completed. [s. 231. (b)]
