1. The licensee had not ensured that the provision of care as set out in the plan of care was documented.

The documentation on the Medication Administration Records (MAR) for two residents was incomplete regarding the provision of a specific treatment. The MAR had boxes to be initialed by day (7-3), evening (3-11) and night (11-7) shifts to indicate that this treatment was being administered correctly. A review of the MAR for an 18 day period for two residents revealed 7 to 10 missing initials.

Registered staff and management of the home confirmed the expectation that the MAR should be initialed on each shift regarding this treatment. [s. 6. (9) 1.]

Additional Required Actions:
