1. The licensee had not ensured that the care set out in the plan of care was based on an assessment of the resident and the needs and preferences of the resident.

A review of the plan of care was completed for an identified resident. The plan of care did not include all interventions and strategies available to the staff to meet the needs and preferences of the resident.

Some staff interviewed were not aware of the unwritten strategies. Management confirmed these strategies should be a part of the written plan of care. [s. 6. (2)]
