**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.  
Plan of care**

**Specifically failed to comply with the following:**

**s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).**

**Findings/Faits saillants :**

1. Resident fell sustaining an injury while walking. When the resident fell they were being assisted by a staff member.

Review of resident's plan of care, revealed that resident was a two person physical assist when walking. This was also confirmed in interview with the home's Physiotherapist.

Director of Nursing confirmed her expectation that the care set out in the plan of care be provided to the resident as specified. [s. 6. (7)]
